International directory for trade fairs

The FAIR Guide is a comprehensive database of trade fairs and exhibitions, exhibitors and event organisers. It offers 24 hour access to 13,000 trade fairs and 2,7 million exhibitors. A number of highly efficient tools for searching and researching make the FAIR Guide an effective advertising medium. It provides an additional opportunity for exhibitors to make their companies better known and thus increase the impact of their attendance at the trade fair.

Basic entry

The free basic entry of your company is published using the data compiled by our team. The entry contains the company name, postal address, telephone and fax numbers and an e-mail address link, which enables internet users with an appropriate browser to contact your company directly. A "fairs" link is located at the end of the entry. This link lists all trade fairs that your company has attended. All entries in the "exhibitors" section are classified according to country, and company names are arranged alphabetically for each country.

Effective advertising

By placing an order, you can purchase an entry in the FAIR Guide at the internet address www.fairguide.com. In the exhibitors section, your company address is graphically highlighted (see pictures "basic entry" and "database entry"). Your database entry is placed at the top of the list of exhibitors for the respective country and includes the following information:

- a) Address: company name, street, city, province/region, country
- b) Contact information: telephone and fax numbers, e-mail
- c) Company homepage and access to the "integrated website".
- d) The "SHOW FAIRS" button in the database entry gives the user an overview of all trade fairs and exhibitions that your company has attended. The database entry in turn is included in all exhibitors' directories of trade fairs that have been announced. The advertising impact increases with the number of trade fairs you have attended. You should therefore keep us informed of all the trade fairs that you have attended in the past and are planning to attend in the future.
- e) The database entry can also include your company logo in the graphic formats JPEG or GIF (not animated) up to a size of 200 x 200 pixels. You can either provide us with the electronic version of your logo or leave its preparation to our own graphic designers. A

one-off processing time of two hours is included in the overall price. You will be invoiced separately for any work in excess of this time.

The "INTEGRATED WEBSITE" link in the database entry and the URL <http://www.fairguide.com/> takes you to a multi-page company presentation. This presentation will from now on be referred to as an "integrated website". The desired URL which connects users to your presentation should contain company-specific characteristics (e.g. "construct_data" for "Construct Data Publishers a.s."). The layout of the integrated website is standardised (for an example, see: http://www.fairguide.com/construct_data/):

"Homepage" (compulsory): HTML page containing company details such as name, address, telephone, fax, e-mail, website, year founded, number of employees, VAT number, annual turnover, up to four contact persons and their positions in the company, regions in which the company operates (regional, national, Western Europe, Eastern Europe, USA/Canada, Middle East/North Africa, Africa, Asia/China/Australia, Latin- and South America/Caribbean or worldwide) as well as possible correspondence languages. In addition to the text, this page can also display the company logo. This service is subject to the same conditions that apply to the database entry. The page is accessed via the link "integrated website".

"Products" (optional): Page with freely formatted HTML for the presentation of products and/or services (e.g. a list of all your products).

"Agencies & representations" (optional): Page with freely formatted HTML for addresses and contact data of agencies and representations.

"Further details" (optional): Page with freely formatted HTML for advertising messages or detailed company presentations. The page can also be divided into subsections.

"Get in contact" (optional): HTML page for direct fax contact. After entering name, address and text, a fax can be sent directly to the owner of the "integrated website". The fax service is free, as long as a standard limit of 50 faxes per month is not exceeded.

Individual text and pictures can be included in the pages "Products", "Agencies and representations" and "Further details". The limit for data provided electronically is 9,000 characters and 15 pictures. If printed material is provided, the maximum is 3,000 characters and 5 pictures. If you require additional services, you will be invoiced separately for the work involved. Please contact our customer service for further information.
